## Director's Message

Welcome to our Fall Newsletter. It has been another exciting and busy term at the [School of Public Policy and Governance](#) and I am pleased to have the opportunity to update you on our School's programs, research, outreach, and student-led activities.

The School is fortunate to be able to draw on the intellectual energy and talents of the many [faculty, staff, students, and alumni](#) affiliated with the School. That energy and those talents fuel the many research, teaching, and engagement efforts the School embarks on each year.

Looking forward to 2016, we are excited to be hosting the next iteration of the Ford+SPPG Conference, an annual event held in partnership with the [Gerald R. Ford School of Public Policy](#) at the University of Michigan.

The conference will take place on March 11-12, 2016 on the very important and timely topic of income inequality.

Next term we also look forward to the next iteration of the Walter Gordon Massey Symposium, jointly organized by SPPG and our partners at [Massey College](#). The 2016 Symposium will take place on March 22-23 and will examine Justice Murray Sinclair's primary recommendation from the Truth and Reconciliation Commission for a new Royal Proclamation for indigenous peoples.

In addition to looking ahead I wanted to take a moment to reflect on all of the exciting activities that have taken place at the School over the Fall term. Continuing the legacy of successful student-led programming, our [Master of Public Policy](#) students continue to demonstrate amazing leadership through their extra-curricular and student-led activities. For instance, this year the [Public Good Initiative](#) has 44 MPP students working as *pro bono* consultants on 13 projects, including 6 new clients: Counterpoint, WomenattheCentrE, Toronto Atmospheric Fund, Centre for Equality Rights in Accommodation, Toronto Alliance to End Homelessness, and Toronto Parks and Trees Foundation. PGI's continued growth and inroads into Toronto's non-profit sector is demonstrative of the quality of the PGI team and the student consultants' work in the community.

SPPG's student-run current affairs radio show, [Beyond the Headlines](#), has also expanded this year and is producing more content than ever before. The BTH team has nearly doubled in size and is now comprised of 23 MPP students. I hope you're listening every Monday from 11:00 am - 12:00 noon on CIUT 89.5 FM.

The [Public Policy and Governance Review](#) recently saw the successful launch of its latest issue, which is available online and in print, and this Fall the SPPG Students' Association elected five First Year MPP students. Please join me in congratulating these students on being nominated and elected to represent the MPP student community.

This Fall also saw the launch of a number of new student initiatives and groups at the School, funded out of the new [Student Policy Innovation Fund](#). These projects include the next iteration of the Municipal Policy Action Case Competition, the Public Sector Innovation Initiative, the Public Policy Business Exchange, and a Gender and Public Policy Conference organized by the student-led [Gender and Public Policy Initiative](#). More details about each of these new and exciting initiatives can be found below.

In addition to these student-led initiatives and activities, the School has been host to a number of other events and activities over the fall term. I offer my sincerest thanks and appreciation to all

## Update from the Mowat Centre

---

The [Mowat Centre](#) is an independent, non-partisan public policy think tank at the School of Public Policy and Governance. Since May, the Centre has published seven research papers on a range of issues.

ONTARIO'S VOICE ON PUBLIC POLICY

The Mowat Centre's most recent report examines the success and challenges in federal, provincial and municipal government efforts to support the development of Canada's economic infrastructure. [From the Ground Up](#) argues that Canada has not realized the full potential of the role of municipal governments in the development of critical infrastructure.

The [Social Architecture](#) series also added two new research reports. In [Growing Pains: Childcare in Canada](#), The Mowat Centre examines the evidence that effective childcare boosts employment, reduces gender inequality and promotes child development. [Lower Risk, Higher Reward](#) examines new stresses on Canada's Retirement System and assesses whether future Canadians will be ready for their retirement.

Building on The Mowat Centre's partnerships with other organizations, the Centre worked with the [Atkinson Foundation](#) to release two studies on community wealth-building. The first, [Community Benefits Agreements](#), looks at how large-scale public projects can be used to realize local economic development goals in communities and how these agreements can be developed in Ontario. The second study, [Anchor Institutions](#), examines the role of large, local institutions - such as municipal governments, universities, and hospitals - in building community wealth.

Since last Spring, Mowat researchers were featured in Canada's major media, including CBC, the *Toronto Star*, the *Globe and Mail*, and the *National Post*, as well as in several local media outlets across Canada. The Mowat Centre also published two [Mowat Opinions](#) for the *Public Sector Digest* and the *National Post*.

[Mowat NFP](#), the Centre's research hub for the not-for-profit sector, released a ground-breaking report in collaboration with the Ontario Nonprofit Network and Toronto Neighbourhood Centres. [Change Work](#) explores the decent work agenda and its potential to increase impact in the not-for-profit sector. The report was featured on the front page of the *Toronto Star* and on CBC's Metro Morning and Superior Morning. Mowat NFP also welcomed two new staff members: [Lisa Lalande](#) is Mowat NFP's new Executive Lead, and [Christine Yip](#) has joined NFP as a Policy Associate.
